A. Activities`

➤ Provision of legal aid and Counseling

Legal aid and Counseling was provided to 36 clients visited CRC center, Women 32 Men 4. Children 0 Reconciliation was done to 3 clients through direct conversation, the rest cases were finished as they were supported with the legal aid and counseling needed.

➤ Reconciliation

Reconciliation was done to three clients under GEWE Project through direct conversation and out of three reconciliations, one was done successful, the other one is ongoing and the last is failed but they were advised to go to Kinondoni Social Welfare for further step

➤ Support

Capital support was given to one client from Kawe, under GEWE Project to facilitate the cost of shelter after her husband chase her and children's out of house. And under IOGT 3 clients were given support.

➤ Follow up on victim's cases

Total number of follow up was done to six clients through visitation three under IOGT Project and three under GEWE Project, phone calls follow up were done to five clients, all under GEWE Project
